That Seller agrees to display item(s) in a prominent place in their store locate at 11895 Grand Commons Ave., Fairfax, VA 22030.

AUTHENTICITY:

Chic Envy Consignment, LLC accepts only authentic designer items. Consignor guarantees the authenticity of all merchandise consigned with Chic Envy Consignment, LLC. Any Consignor item delivered to Chic Envy Consignment, LLC and deemed to be unauthentic by Chic Envy Consignment, LLC or any qualified 3rd party, will either be returned to Consignor for a twenty five dollar (\$25) processing fee, or will be destroyed or discarded.

In order to qualify for the Chic Envy Consignment, LLC Seal of Authenticity, Designer handbags must be delivered to Chic Envy for inspection and have two or more of the following supporting materials:

- Original sales/gift receipt**
- Manufacturer authentication card**
- Legible Serial Number or Hologram**
- Original Price Tag**
- Original Packaging**
- Manufacturer Registration Card**

Based on the above The Seller will make every attempt to obtain the best possible price for the consigned merchandise and will accept no less than \$ _____ as purchase price. If after the items have been transferred to seller, there is no current appraisal and one is required via sellers research prior to entering this mutually agreed upon purchase price. This amount may be agreed upon at a later date telephonically, confirmed via fax or email and entered by seller.

That for their efforts Seller is entitled to retain (percent):

50 % of the purchase price for a sale less than \$999

60 % of the purchase price for a sale of \$1000 - \$1999

70 % of the purchase price for a sale of \$2000 or more

That should a sale be effectuated, Seller shall forward a check for the amount of the full purchase price less the aforementioned (percent) unless discussed after this agreement is signed and mutually added telephonically and confirmed by email or fax and prior to the final settlement amount which will be transferred to Consignee within 10 days business days of the receipt of same. **Chic Envy, LLC is not responsible for any lost, stolen, misplaced or thrown out checks. A \$32.00 stop check fee will be deducted from payment for any requests to reissue a check.**

That Consignee agrees to leave the merchandise with Seller for a minimum of (time) 90 days.

If a dispute arises out of or relates to this agreement, or the breach thereof, and if the dispute cannot be settled through negotiation, the parties agree first to try in good faith to settle the dispute by mediation administered by the Fairfax County Better Business Bureau within the state of Virginia.

CONDITION:

All consigned merchandise must be delivered to Chic Envy Consignment, LLC in excellent condition be "ready to sell." Consignor must disclose to Chic Envy Consignment, LLC, prior to the acceptance of merchandise by Chic Envy Consignment, LLC, any and all flaws, damage, and/or alterations to the merchandise. In cases where damage or alterations are not disclosed, Chic Envy Consignment, LLC reserves the right to terminate the consignment agreement at any time and without notice.

OWNERSHIP:

The Consignor guarantees that he/she is the true and lawful owner of any and all merchandize consigned with Chic Envy Consignment, LLC. Consignor agrees to indemnify and hold harmless Chic Envy Consignment, LLC for any damages arising from any and all claims, demands, losses, causes of action, damage, lawsuits, judgments, including attorneys' fees and costs, to the extent caused by or arising out of or relating to the unlawful ownership of merchandise.

AGREEMENT:

This agreement may not be modified unless agreed to in writing and signed by Chic Envy Consignment, LLC and the Consignor. All reasonable disputes will be directed to the Fairfax County Better Business Bureau within the state of Virginia where the dispute will be handled accordingly. This constitutes the full agreement and supersedes any other agreement whether in writing, verbal or otherwise and may not be changed in any way without mutual agreement and marks thereof by these assignees including this cosigner and this representative or other legal representative of Chic Envy Consignment, LLC. I have read, and hereby acknowledge my agreement to the conditions of this contract.
